Executive Summary

Two credit sales were completed in 2014; one to Washington State Department of Transportation for wetland credits in the WRIA 15 Service Area, and one to Mr. Jon Koloski in the Marine Service Area. In 2014 three mitigation project properties were pursued. The Irene Pond wetland property was acquired in September 2014. Funds from the Program Administration, Land Fee and Mitigation Projects accounts were used to complete due diligence (environmental site assessment and hazardous materials survey); for legal counsel support for the preparation of acquisition documents and the preparation of site protection instruments; for closing and acquisition of the property; and for design and permitting for buffer enhancement actions. A second property, Harding Creek, was investigated but not acquired due to acquisition valuation issues. Funds were spent out of the Program Administration account for staff and legal support in pursuing this property. The third property, Port Gamble mill site, was investigated in 2014 and will continue to be developed in 2015. Funds were spent out of the Mitigation Projects account for 10% and 30% design and site soil characterization work at the Port Gamble southern mill site. Program Administration funds were utilized to support staff work in developing a mitigation project at this site and to support legal counsel in preparing an Option Agreement and contract documents to acquire development rights. Two Spending Agreements were executed in 2014; one for the Irene Pond project and one for the Port Gamble mill site project.


