March 22, 2017: Kim Schaumburg, consultant, contacted the ILF Program concerning mitigation for impacts for a float re-decking project in Union, WA near Alderbrook. Her client has been notified by WDFW that their float re-decking project may require mitigation should they not be able to achieve full grating and minimization of grounding of the float on intertidal habitat. A credit cost estimate was provided to Ms. Schaumburg for 500 square feet of intertidal non-vegetated habitat impacts.

US Navy, NAVFAC NW potential credit sale for the Navy's Land Water Interface (LW)) project. The LWI project would require mitigation credits for impacts to marine/nearshore aquatic resources. The Use Plan for this credit sale is in review by HCCC staff and USACE regulatory staff.
