1. Summary of all inquiries received, which may include inquiries from potential project permit applicants and regulatory entities.

The U.S. Army Corps of Engineers contacted the HCCC to inquire about the potential to utilize the HCCC ILF Program to mitigate impacts of the Mason County Parks and Trails Union Boat Ramp project. The mitigation needs are unknown at this time and contact by Mason County staff has not occurred. The project may require mitigation for nearshore habitat; which could be mitigated through the ILF Program.

2. Summary of all pending credit sales and related correspondence with regulating entities and project proponents.

There is a pending credit sale for the WSDOT Belfair Highway Widening and Safety Project. This project will require mitigation for unavoidable adverse impacts to wetlands totaling 0.08 acres. The Use Plan has been finalized and WSDOT is preparing a contract document for HCCC review. A Preliminary Statement of Sale has been drafted and provided to WSDOT for review.
