They are a small 501(c)(3) non-profit who provide beaver habitat evaluations, co-existence strategies & techniques for retaining beavers onsite, creating & installing beaver dam analogs, and relocation of beavers to restoration sites. Hood Canal Local Integrating Organization (LIO) allocates funding for On-site Septic Action Plans projects. HCCC Board directed the LIO to allocate \$183,000 of newly awarded funds from the Environmental Protection Agency (EPA) via the Puget Sound Partnership (PSP) to support implementation of priority water quality protection actions in Mason and Jefferson Counties.

First summer chum salmon return to Uncas Preserve on Snow Creek this fall. Fish returned higher in the system than had ever been documented since their decline. <u>View a video of these intrepid fish from North Olympic Salmon Coalition</u>.

WA Dept. of Ecology's Coastal Zone Management (CZM) Program launches survey to advance equity in Washington's coastal resilience efforts. Survey insights will directly inform two key initiatives: a strategic plan for the state's interagency Coastal Hazards Organizational Resilience Team (COHORT) and an action and implementation plan for the CZM Program. The survey is expected to take 15 to 20 minutes, and is confidential. Respond by Jan 10. Survey linked here.

NOAA released updated maps and datasets on employment in Coastal Inundation **Zones**. On November 12, NOAA released updated Employment in Coastal Inundation Zones data and new maps on NOAA's <u>Digital Coast website</u> and GeoPlatform. The first-of-its-kind data depicts the number of businesses and jobs potentially impacted by hurricane storm surge, 100-year flood zones, sea level rise, and tsunamis.

More king tides are coming! The second series of king tides, the highest high tides of the year, was December 13-17, 2024. The third series of winter king tides this season is January 11-15, 2025 - check the Sea Grant king tides calendar to find more details for your area. Anyone with a camera can help document the extent of these extreme high tides and help us catch a glimpse of

what sea level rise will look like in our region. In Washington, photos of King Tides can be uploaded to the MyCoast App.

Watch All Our Relations: Tribute to the Orca. Se'Si'Le, an Indigenous-led nonprofit organization based in Washington State, collaborated with Salish Sea and Northern Straits Native Nations and NGOs to host an Indigenous-centered public event during Orca Action Month, June 2024 at the Seattle Aquarium. All Our Relations: Tribute to the Orca is a moving 7-minute film drawing on footage from this event and other interviews. It delivers powerful, somber and urgent narratives from regional Indigenous leaders. Tribute to the Orca highlights Indigenous communities' ancient kinship with orcas and salmon, and the importance of reciprocity in our relationship with our caretaker: Mother Nature. This short film includes a special focus is on the Southern Resident orcas whose survival, like the survival of Indigenous lifeways here in the Pacific Northwest, depends on scha'enexw (the Salmon People).

Puget Sound Habitat, Shellfish, and Stormwater Strategic Initiative Leads (SILs) presented the outcomes of the SIL 1.0 Cooperative Agreements and Looking Ahead in Puget Sound Recovery. New report and dashboard show Climate Commitment Act investments. A <u>new annual report</u> and <u>online dashboard</u> show how Climate Commitment Act (CCA) revenue was spent on projects ranging from wildfire resiliency and salmon habitat restoration to pedestrian and biking infrastructure, energy bill assistance, and new clean energy sources.

Puget Sound Partnership and the Northwest Indian Fisheries Commission co-hosted a "**Fish and the Farm Bill**" panel on December 17th. The recording is available <u>here</u>.

New indicator tracks & visualizes ocean acidification in Washington. WA Dept. of Ecology is measuring the impacts of carbon pollution to help support healthy ocean habitats, and assist communities in adapting to change. Ocean acidification threatens marine wildlife, people's livelihoods, cultural traditions, and the state's economy. <u>Learn more</u>.

Puget Sound Habitat Strategic Initiative Lead (SIL) announces \$1.75 million of EPA Puget Sound Funds into five proposals to advance Puget Sound habitat recovery. The investments are distributed across two priorities that support healthy shorelines: (1) Restoration effectiveness of soft shore alternatives to hard armor; (2) Planning for sea level rise and climate related hazards to nearshore habitat. WA Dept. of Fish and Wildlife Aquatic Lands Enhancement Account (ALEA) grants support volunteer projects that benefit the state's fish and wildlife resources and the public's enjoyment of them. Project types include habitat restoration, scientific research/community science, public education and outreach, facility development and artificial fish production. Closes Feb 28. More info.

NOAA Restoring Fish Passage Through Barrier Removal. Up to \$75 million in funding is available through the Restoring Fish Passage through Barrier Removal funding opportunity. This funding will support the locally led removal of dams and other in-stream barriers. Closes Feb10. More info.

Bureau of Reclamation WaterSMART Aquatic Ecosystem Restoration Projects. FY25-26's \$95M of funding focuses on restoring and protecting aquatic ecosystems. Due Apr 15. <u>More info.</u>

Bureau of Land Management's (BLM) Aquatic Resources Program. This new grant initiative is aimed at advancing the restoration, protection, and sustainable management of aquatic habitats and water resources on public lands. Due Feb 14. <u>More info</u>.

Restore America's Estuaries - National Estuary Program Watersheds Grant Program. This is a nationally competitive grant program designed to support projects that address urgent, emerging, and challenging issues threatening the well-being of estuaries within the 28 NEPs. LOIs due Jan 17. More info.
